ARTICLE II MEMBERSHIP

SECTION 1. ELIGIBILITY

There shall be four types of membership open to all persons eighteen years of age and older who are in good standing with the American Kennel Club, the Doberman Pinscher Club of America and who subscribe to the purposes of the club, and one type of membership open to persons under the age of eighteen.

Regular Membership (Individual) — Enjoys all club privileges including the right to vote and hold office.

Household Membership — Two (2) adult members residing in the same household, each eligible to vote.

Lifetime Membership – Open to members voted by fellow members to lifetime membership, will not pay any annual dues, will have all club privileges, but will not count as part of quorum.

Junior Membership – Open to all persons less than eighteen years of age who otherwise meet the requirements for active membership. Junior members shall pay dues, may not vote nor hold office and will not count as part of quorum.

Associate Membership – Open to all persons over 18 years of age who otherwise meet the requirements for active membership. Associate members shall pay dues and are entitled to all club privileges except voting and office holding (offered to individuals who live outside of the club's area; also offered to individuals who live in the club's area but are not active). Because they are ineligible to vote, Associate Members will not count as part of the quorum and Associate Members shall not engage in discussion of a motion on the floor.

While membership is to be unrestricted as to residence, the Club's primary purpose is to be representative of the breeders and exhibitors in its immediate areas.

New membership applicants must:

1. Come to the 1st meeting, turn in application prior to the meeting. There will be a 1st reading.
2. They will not be allowed to attend the meeting where their 2nd reading takes place and the application is voted on.
3. The Secretary will inform the applicant of the results of the votes.

(Associate Membership Applicants do NOT have to attend any meeting for Membership requirements)

PROVISIONS OF MEMBERSHIP BENEFITS

- A member is required to have been a member in good standing for a minimum of 3 uninterrupted years prior to being eligible for the subsidy of Health Day. Variance of this Standard Policy shall be discretionarily allowed by the PSDPC Board of Directors. 12.12.16 BOD
- A member is required to have been a member in good standing for a minimum of 3 uninterrupted years prior to being listed in the Website, any other Social Media Sources, or in a printed directory as a Breeder.
